The plan identified eleven heritage goals

including important work involving museums, archives and their collections, the establishment of heritage awards and greater recognition for heritage advocacy, and the raising of public awareness of heritage issues.

The members of the Edmonton Heritage Council will be the heart of the Council. They will populate the networks, animate the discussion, plan and develop programs, provide leadership, and form the Board of Directors of this exciting new organization.
